Claims-Made or Occurrence Policy

Limits from \$100,000 per occurrence and \$300,000 aggregate up to \$5 million per occurrence and \$5 million aggregate are available to cover loss from dental treatment and peer review services.

Medical Expenses Coverage

\$5,000 per each patient and \$10,000 aggregate

Administrative Disciplinary Actions

Defense expense up to \$25,000


